Working with Families Impacted by Parental PTSD

April 27th from 1–3:15 EDT

When parents suffer from mental illness, the entire family is impacted. This training explores the effect on children when their parents have a mental health diagnosis of Post-Traumatic Stress Disorder (PTSD). Participants will also engage in an exercise to help them have greater empathy for parents suffering from PTSD. This training offers practical recommendations on how to facilitate support and change for parents who may struggle with their symptoms. Participants will also develop informal action plans to assist them in their own professional work with families.

This intermediate level training is designed to support caseworkers, social workers, counselors, and other helping professionals who are working alongside families impacted by parental PTSD. This informative session will include didactic lecture, as well as group interaction, personal reflection, and a time for Q & A.

Participants will be able to:

1. Describe at least 5 key effects PTSD may have on a parent's ability to parent.
2. Identify at least three core strategies to work more effectively with families impacted by parental PTSD.
3. Develop an action plan to assist them in their work with families impacted by parental PTSD.
