PTSD in Teens 3 hrs (One 3-hr virtual session) April 14th from 1 pm- 4 pm EDT

This 3-hour intermediate level training will be useful for psychologists, social workers, clinicians, and other helping professionals working with teens who have been diagnosed with Post Traumatic Stress Disorder (PTSD). The course will increase participants' professional strategies to better support their clients on the path to healing.

Working with a teen who is diagnosed with PTSD can be challenging. It is also an opportunity to help a teen heal and move toward Post Traumatic Growth. We will review the diagnosis of PTSD and consider how the usual symptoms impact developmental tasks and day-to-day life. Teens with PTSD often exhibit challenging behaviors: flashbacks, sleep disturbance, suicidal ideation, strong reactions to triggers, struggles with getting things done, and relationship problems.

We will consider strategies we can use to help a teen understand their diagnosis, reduce symptoms, and focus on healing. The training will incorporate time to develop an action plan reviewing resources and coping skills helpful for teens and their caregivers.

Participants will be able to:

1. Describe the diagnosis of Post-Traumatic Stress Disorder and its impact on the developmental tasks of the teen years.
2. Develop effective communication strategies to use with teens with PTSD, and their parents/caregivers, to support optimal treatment outcomes.
3. Identify typical behaviors present in teens with PTSD along with effective treatment methods to address them at home and in the community.
4. Plan resources about managing the symptoms of PTSD to share with teens and their families.

Laura Gaines, MSW, LISW-S. Laura has 20 years of experience as a child and adolescent mental health clinician and crisis text line volunteer. In addition to her professional experience, she has experience as an adoptive parent of a (now adult) daughter who is diagnosed with PTSD. mental health. She has been an Ohio Child Welfare Training Program trainer and curriculum developer for over 20 years. Her trainings focus on child development, mental health, developmental disabilities, ethics, trauma informed care, resilience and each person's individual solutions to life's challenges.
